## **1.2 Background of The Research**

As a result, Malaysia's prime minister ordered the closure of all educational institutions. As a result, learning that is normally done in person is now done online (Arwansyah, Faisal, Masrurih, Marpuah, 2022).

According to Isman (2017) in Muhammad, online learning is a method of learning that involves the use of the internet network. Students that learn online have greater flexibility in their learning. Online classroom systems allow students to communicate with teachers. The purpose of this study is to identify the characteristics that impact Malaysian students' adoption of online classroom platforms (Assidiqi & Sumarni, 2020).

# **1.3** Problem Statement

Based on the background above, it explains that the corona virus that originated from Wuhan has spread to Malaysia. According to statistics acquired in August 2021, the number of people in Malaysia who have been exposed to the corona virus has reached 1,163,291. As a result, everyday activities are restricted and limited to the confines of the home. This prompted the Malaysian prime minister to give directives to close all educational institutes. Therefore, learning that is usually offline becomes online.

## 1.4 Research Questions

Based on the background described previously, the formulation of the problem in this study is:

- a) Is there an effect of perceived ease of use on perceived usefulness?
- b) Is there an effect of perceived ease of use on attitude towards behavior?
- c) Is there an effect of perceived usefulness on attitude towards behavior?
- d) Is there an effect of perceived usefulness on behavior intention to use?
- e) Is there an effect of attitude towards using on behavior intention to use?
- f) Is there an influence of perceived ease of use and attitude towards behavior on behavioral intention to use?
- g) Is there an influence of perceived usefulness and attitude towards behavior on behavioral intention to use?

# 1.5 Research Objectives

Based on the formulation of the problem above, the objectives of this study are as follows:

- a) To find out the effect of perceived ease of use on perceived usefulness
- b) To find out the effect of perceived ease of use on attitude towards behavior
- c) To find out the effect of perceived usefulness on attitude towards behavior
- d) To determine the effect of perceived usefulness on behavior intention to use
- e) To find out the effect of attitude towards using on behavior intention to use
- f) To determine the effect of perceived ease of use and attitude towards behavior on behavioral intention to use

g) To determine the effect of perceived usefulness and attitude towards behavior on behavioral intention to use

# 1.6 Significance of The Research

Based on the explanation above, the benefits of this research are as follows:

- a) For researchers, as a source of information and a reference while conducting research on the elements that influence student acceptance of online learning platforms in Malaysia.
- b) For readers, as a source of additional knowledge, and broad insight.

#### **1.7** Scope of The Research

This study focuses on explaining the factors that influence student acceptance of online classroom platforms in Malaysia. Researchers want to know how much influence the online class platform has in Malaysia. The researcher made this research selectively starting from the variables to the object of the research. The researcher made a title that was close to the daily lives of students because it was felt that the problem of student admissions on the online class platform was very important. Because during the COVID-19 pandemic, the online class platform became an application that was used every day when seeking knowledge. Therefore, the researcher took the title of the study.

In this study the students were asked to fill out a questionnaire to answer the responses from this study. The questionnaire used is google forms. In this study, more than 200 students were taken as samples. The 200 students consisted of 7 faculties, namely the Faculty of Business Management & Professional Studies (FBMP), the Faculty of Information Sciences & Engineering (FISE), the Faculty of Health & Life Sciences (FHLS), International Medical School (IMS), School of Education & Social Sciences (SESS), School of Pharmacy (SPH), and School of Hospitality & Creative Arts (SHCA).

The faculties that are sampled must be the Faculty of Business Management & Professional Studies (FBMP), Faculty of Information Sciences & Engineering (FISE), Faculty of Health & Life Sciences (FHLS), International Medical School (IMS), School of Education & Social Sciences (SESS), School of Pharmacy (SPH), and School of Hospitality & Creative Arts (SHCA).

# **1.9 Definition of Key Terms**

Several definitions are offered to clarify the words used in this study:

a) Perceived Ease of Use

According to Davis (1986) in (Alshurideh et al., 2019), perceived ease of use is the belief that someone when using a certain system will be free from effort. Meanwhile, according to Jagiyanto (2007) in (Setiawan et al., 2018) interpreting perceived ease of use is a belief about the decision-making process.

b) Perceived Usefulness

According to Davis (1986) in (Wicaksono & Maharani, 2020), perceived usefulness is the belief of individuals or groups in a system that can facilitate their work. According to (Jason & Siti Aishah, 2021) perceived usefulness can also be interpreted as an effective application to do.

c) Attitude Towards Behavior

Attitude towards behavior according to Davis (1989) in (Sugiri et al., 2017) namely positive and negative feelings from someone if they have to do the behavior that will be determined. Meanwhile, according to Mathieson, attitude towards behavior is behavior as a user evaluation of interest in using the system.

d) Behavior Intention to use

According to (Sugiri et al., 2017) behavioral intention to use is a person's desire to perform a certain behavior. A person will perform a behavior if he has the desire or intention to do it.

e) Online class platform

Platform is a digital container that is widely used by humans for various purposes. In simple terms, the platform is a container that is used to run a system according to the program plan that is made. For example, for online learning, the platform used is based on digitalization (Selvakumar et al., 2022).
